It is notified to all the prospective bidders that with reference to NIT No. APGVB / Housekeeping – TS / 2022-23 / 2 dated 7<sup>th</sup> May 2022, Addendum dated 17<sup>th</sup> may 2022 and queries raised in the pre-bid meeting held on 20<sup>th</sup> May 2022, the following changes are being made to the tender document.

1. **Solvency Certificate:** It was advised, in para 5 of Annexure – A (eligibility criteria) of the NIT, to submit a solvency certificate obtained not earlier than 1<sup>st</sup> December 2021. Now that considering the concerns of the prospective bidders, it has been decided to provide an option to submit an undertaking that the bidder has a solvency of Rs.100 lakhs. However, the bidders, who have opted to furnish an undertaking in lieu of Solvency Certificate from a Scheduled Bank, on emerging as L-1 shall invariably submit a Solvency Certificate, worth INR 100 lakhs obtained from a scheduled bank on or after 31.05.2022, within 7 days from the date of receiving intimation on emerging as L-1.

2. The “DETAILS OF ALL ‘SIMILAR’ WORKS COMPLETED DURING THE LAST SEVEN YEARS”, in Annexure-4 to the NIT to be read as “**DETAILS OF ALL ‘SIMILAR’ WORKS COMPLETED DURING THE LAST FIVE YEARS**”.

3. **Queries raised by the bidders:**

a) **If two or more bidders have submitted same Financial bid and Scored equally in Technical evaluation Matrix, what criteria will be given priority for selection of L-1?**

**Ans:** This scenario may be hypothetical. However, on such case the tender committee will notify the criteria in best interest of the Bank.

b) **If the bidder has different types of work experience at a same client, how the technical evaluation is made?**

**Ans:** The experience in similar works will only be considered.

Note: “Similar Completed Work” shall mean successful completion of Integrated Facility Management and House Keeping Services work for Public Sector Banks, Financial Institutions, Central & State Govt. departments/ Organizations, Public Sector Undertakings etc.

4. This corrigendum shall form part of the tender document and the bidders shall sign the same and submit along with technical bid.
